This course is an integral part of two special tracks sponsored by the EU Center: "Atlantis", dedicated to the triangular relationship between the EU, the US and Latin America, and "Mare Nostrum", on Mediterranean studies.

This course will first deal with the fundamental dimensions of the European Union, its history and institutions, its essence and its theoretical framework, as well as its potential as a model and point of reference for regional integration around the world in a comparative approach. The second part will be dedicated to systematic analysis of selected cases of regional integration in key parts of the world. After a summary consideration of comparing the EU's nature with other cases of regionalism in the European vicinity, in Asia and Africa, the course will deal with EU's linkages with the Americas. Consideration will be given to the North American Free Trade Area (NAFTA), as an example of the influence of the US-led model of regional integration and cooperation, and the planned Trade and Investment Partnership (TTIP) between the EU and the US, and its implications in Latin America. Discussions then will deal with the EU's practice of North-South development aid and cooperation in the Caribbean and

Central America. The course then will review the links between the EU in the wide South American region, studying the development of regional cases such as the Andean Community and MERCOSUR, and newcomers such as UNASUR, the Community of Latin America and Caribbean States (CELAC), the Alliance of the Pacific, and other frameworks such as the ALBA and the Ibero-American Community .

Requisites

- (1) One short paper (500-600 words) dealing with one important aspect, institution, period of trend of the EU as model or point of reference for regional integration. Use 4-5 sources of reference. 20%/ 100%
- (2) One short paper (500-600 words) on an example of integration-collaboration in the EU neighborhood, Africa or Asia. "What are the most salient features that makes this example of cooperation of states a model of integration? Is it possible to observe defects? Use 4-5 sources. 20%/ 100%
- (3) One short paper (500-600 words) on an example of integration-collaboration in the Western Hemisphere with the presence of the United States (NAFTA, FTTA, TTIP, etc.). How is the imprint of the United States noticed? Negative? Positive? Use 4 sources. 20%/100%
- (4) One short paper (500-600) on an example of integration-collaboration in Latin America-Caribbean. Is this example of Latin American cooperation a sign of progress towards some stages of building a real Common Market? 20%/100%
- (5) One paper expanding/correcting or combining on papers 1, 2, 3, 4 (600-800 words). Just use previous texts and expand, correct, confirm 10%/ 100%
- (6) Attendance and active class participation. 10%/ 100%
 Having your video turned on in class is mandatory. Having your video off may result in counting you as absent from class.

Class Attendance Policy:

Attendance in the virtual class is required as scheduled. If you cannot attend the virtual class due to illness or other reason, you must contact the instructor. Unexcused absences from the classroom may affect your grade or lead to failing the course.

Concept and Structure of papers:

Title (innovative), introduction-lead (Who, when, what, where...), main corpus, conclusion.

Use the **Hemingway** style, or United Press International (UPS) editing code: short sentences, affirmative, no subordinate constructions. This novelist used to say that he managed to learn how to write following the style instructions of UPI. At that time, editors prescribed the frugal economy of text volume because long dispatches were very expensive using the usual telex technology.

Sources: a minimum of 4-5 (balance of books, academic articles, think tank papers, EU official documents, and possibly one press report of recent publication –1-2 months); it is also expected that in each of the papers at least one **academic source produced by the EU Center** is used and cited.

Format: any, but consistent

Documentation: complete data: author (complete last name and first name, or name of institution), title, date (complete), pages, and electronic link if accessed through internet. Insert citation within text (after a word, line, of paragraph) or in a parenthetical method, not only listing at end of essay

Language: impeccable spelling, composition subject to editing by colleagues or UM Writing Center. Ask yourself this question: Would I send this to the NY Times/ Financial Times or good think tank, for consideration and publication? You would not? Then, don't send it to me.
